PLAYER APPLICATION and PARTICIPATION AGREEMENT

Please Read The Following Carefully Before Signing

I, the undersigned hereby acknowledge that engaging in athletic sports- including the tennis programs and activities offered and conducted by Top Seed Tennis Academy, Inc. But notwithstanding such danger and risks, and as an express condition of being allowed to participate in Top Seed s tennis programs and activities, the undersigned, for himself/herself/ as parent or guardian of the above-named player, freely and voluntarily accepts all risks and hazards associated with or incidental to participation in Top Seed s and activities, including use of the facilities where such programs are conducted.
